- requests sensitive data or contains personal information such as names, e-mail addresses or telephone numbers
- is obscene, defamatory, insulting, salacious, abusive, discriminatory, glorifies violence or is degrading (including pictures, videos, links or similar)
- involves politics or religion
- violates anyone else's copyrights or intellectual property rights
- is commercial or promotional in nature
- violates the rules of the respective social media channel

Our correspondence languages are German and English. We will delete posts written in any other language.

Please inform yourself about the applicable rules of the respective social media channel.

We reserve the right to exclude users who publish the above-mentioned content from the use of the respective channel or profile. There is no fundamental right to use a Bionorica profile or channel.
